




The Economic Alliance of Kankakee County is a publicprivate partnership that works to create jobs and expand the economic base by improving the local business climate in Kankakee County.








#### RIVER EDGE REDEVELOPMENT ZONE KANKAKEE

  - Spruce Street resurfacing
  - Anticipated start late 2024



Kankakee County unemployment February 2024




IL unemployment February 2024


