ROUTE 50 RENOVATIONS

- \$13.8M Reconstruction of Route 50 and Armour Road
- Began in March 2023
- Dedicated turn lanes, traffic signals and lighting, utility relocation, sidewalks and curbs



IDOT PROJECTS

- **I57 at Manteno:** \$80M for Exit #322 reconstruction
- 157 at East Court Street: \$95M interchange redesign & build
- **I57 at US 45/52:** \$70M for Exit #308 rebuild
- IL Rte 114 in Momence: \$19.5M resurfacing and drainage
- IL Rte 50 from Brookmont Blvd. to US 45/52: \$17M for pavement
- Rte 113 from Will County to Edgewater Dr.: \$3.5M resurfacing & culvert replacement
