




The Economic Alliance of Kankakee County is a publicprivate partnership that works to create jobs and expand the economic base by improving the local business climate in Kankakee County.



BRADLEY-BOURBONNAIS COMMUNITY HIGH SCHOOL DISTRICT 307

- High School District 307 referendum passed by 54.63%.
- \$70M for safety, security and technology improvements; heating, cooling and ventilation systems; fine arts facilities; eliminating mobile classrooms, renovating science labs, building and equipping a fieldhouse, expanding cafeteria and food service area.
- Expected start Fall 2025, completion in 2027.





BOURBONNAIS FIRE PROTECTION DISTRICT

- Approved .21% tax rate increase to increase staffing levels for the department.
- First successful referendum since 1975, when the ambulance service was initiated.
- Serves 36,000 residents over 36 square miles in the Village of Bourbonnais, portions of Bourbonnais
 Township, and Ganeer Township.





KANKAKEE COUNTY HOUSING MARKET YEAR-OVER-YEAR OCTOBER








